RESOLUTION DECLARING THE FAILURE of BIDDING RE: Site Development (Rebidding - Utilizing the Design and Build Scheme)/INFRA-2021-04
AND NON-RESPONSIVENESS OF BIDS OF LONE BIDDER
BERTO LUCCI BUILDERS & SUPPLY

WHEREAS, the Bids and Awards Committee advertised the Invitation to Bid for the abovementioned project on PhilGEPS on December 3, 2020;

WHEREAS, the Pre-bid Conference was conducted on December 11, 2020, 03:00 pm, with only one bidder, Berto Lucci Builders & Supply, in attendance;

WHEREAS, the Opening of Bids was conducted on December 23, 2020, 03:05 pm, with only one bidder, Berto Lucci Builders & Supply, in attendance;

WHEREAS, during the opening of the first envelope, Berto Lucci Builders & Supply presented an Omnibus Sworn Statement inconsistent with the Required Forms indicated in the General Procurement Policy Board (GPPB) Resolution No. 16-2020, Section 6.0 Mandatory Provisions of Required Forms, i.e., the bidder's submitted Omnibus Sworn Statement lacks the following "[NEW]" provisions stated under 6.1.e Omnibus Sworn Statement:

ii. Bidder is not "blacklisted" or barred from bidding by the Government of the Philippines or any of its agencies, offices, corporations, or local government units, including foreign government/foreign or international financing institution whose blacklisting rules have been recognized by the GPPB, <u>by itself or by relation</u>, <u>membership</u>, <u>association</u>, <u>affiliation</u>, <u>or controlling interest with another blacklisted person or entity as defined and provided for in the Uniform Guidelines on Blacklisting</u>;

ix. In case advance payment was made or given, failure to perform or deliver any of the obligations and undertakings in the contract shall be sufficient grounds to constitute criminal liability for Swindling (Estafa) or the commission of fraud

WHEREAS, under Section 35.1 "Failure of Bidding" of 2016 Revised Implementing Rules and Regulations of Republic Act 9184, the BAC shall declare the bidding a failure when:

c) All bids fail to comply with all the bid requirements or fail post-qualification, or in the case of Consulting Services, there is no successful negotiation;

WHEREAS, we, the Bids and Awards Committee, hereby resolve to:

- 1. Declare the failure of bidding for the project Site Development (Rebidding Utilizing the Design and Build Scheme)/INFRA-2021-04;
- 2. Declare the submitted bids of Berto Lucci Builders & Supply, as a loner bidder, non-responsive.
