DECLARING SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF SECURITY SERVICES FOR F.Y. 2021/GOODS-2021-01

WHEREAS, the Philippine Science High School- CALABARZON Region Campus advertised the Invitation to Bid for the Procurement of Security Services for F.Y. 2021/Goods-2021-01 through a posting on PhilGEPS (Philippine Government Electronic Procurement System) on November 17, 2020.

WHEREAS, the Approved Budget for the Contract (ABC) of the project is **Two Million One Hundred Two Thousand Five Hundred Fifty-Four Pesos and 59/100 (P2,102,554.59)** allocated under the 2020 National Expenditures Program (NEP).

WHEREAS, it was stated in the Invitation to Bid that the open competitive bidding shall be done in compliance to the provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the Government Procurement Reform Act.

WHEREAS, a pre-procurement conference was held on November 16, 2020 through video conferencing (google meet) to discuss, review, and finalize the details of the project.

WHEREAS, a pre-bid conference was held on November 25, 2020 at the Conference Room, Administration Building, PSHS- CALABARZON Region Campus, Sitio Sampaga West, Barangay Sampaga, Batangas City. In attendance during the said conference were representatives of the bidders, Maximum Security & Services Corporation and Leon Force Security and Investigation Agency, Inc., and observers from the Philippine National Police-Batangas City.

WHEREAS, in response to the said advertisement, only one supplier expressed its intent to bid on the said project and purchased the Bidding Documents.

WHEREAS, the submission and opening of bids was held on December 7, 2020 at the Conference Room, Administration Building, PSHS- CALABARZON Region Campus, Sitio Sampaga West, Barangay Sampaga, Batangas City.


WHEREAS, MAXIMUM SECURITY & SERVICES CORPORATION submitted complete bidding documents and the only bidder in attendance during the opening of bids.

WHEREAS, upon opening, review and evaluation of the eligibility, technical, and financial documents, it was established that MAXIMUM SECURITY & SERVICES CORPORATION

had the single calculated bid with a bid price of Two Million One Hundred One Thousand Eight Hundred Twenty-Two Pesos and Twenty Centavos (Php 2,101,822.20), within the ABC.

WHEREAS, a post-qualification evaluation was conducted by members of the Technical Working Group (TWG) to examine, verify, and validate all the eligibility, technical, and financial requirements submitted by the bidder. They likewise conducted online checks from available government databases, telephone interviews with official representatives of the bidder's clients, and a video conference with the representatives of the bidders.

WHEREAS, upon post-qualification evaluation, Maximum Security & Services Corporation was deemed qualified in all the requirements and conditions specified in the bidding documents and was therefore established as a responsive bidder.

NOW, THEREFORE, we, the members of the Bids and Awards Committee for Goods and Consulting Services, hereby RESOLVE as it is hereby RESOLVED

- a) To declare MAXIMUM SECURITY & SERVICES CORPORATION as the SINGLE CALCULATED AND RESPONSIVE BIDDER with a total bid quote amounting to TWO MILLION ONE HUNDRED ONE THOUSAND EIGHT HUNDRED TWENTY-TWO PESOS AND TWENTY CENTAVOS (Php 2,101,822.20),
- b) To recommend award of contract to MAXIMUM SECURITY & SERVICES CORPORATION, and
- c) To recommend for approval by the Campus Director of the Philippine Science High School- CALABARZON Region Campus the foregoing findings.


