# Contract Agreement Form for the Procurement of Security Services for FY 2021 / GOODS-2021-01

#### CONTRACT AGREEMENT

THIS AGREEMENT made the <u>08</u> day of <u>January</u> 20 <u>21</u> between PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS Brgy. Sampaga Batangas City of the Philippines (hereinafter called "the Entity") of the one part and MAXIMUM SECURITY AND SERVICES CORPORATION of Suite 202, 2<sup>nd</sup> Floor, Unified Bldg., #6 Denver Street, Cubao, Quezon City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Security Services for FY 2021 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of TWO MILLION ONE HUNDRED ONE THOUSAND EIGHT HUNDRED TWENTY TWO PESOS & 20/100 only (Php 2,101,822.20) (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or



- 3. In consideration for the sum of TWO MILLION ONE HUNDRED ONE THOUSAND EIGHT HUNDRED TWENTY TWO PESOS & 20/100 only (Php 2,101,822.20) or such other sums as may be ascertained, MAXIMUM SECURITY AND SERVICES CORPORATION agrees to provide Security Services for FY 2021 in accordance with its Bid.
- 4. The PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
