

INVITATION TO BID FOR THE PROCUREMENT OF SECURITY SERVICES FOR F.Y. 2020

1. The Philippine Science High School – CALABARZON Region Campus, through the 2019 National Expenditure Program intends to apply the sum of **One Million Eight Hundred Sixty Three Thousand Three Hundred Ten Pesos and 80/100 (PhP1,863,310.80)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of Security Services for F.Y. 2020**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Philippine Science High School – CALABARZON Region Campus now invites bids for the **Procurement of Security Services for F.Y. 2020**. Delivery of the Goods is required *on January 1, 2020*. Bidders should have completed, within *two years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. The contract duration for the security manpower services covers January 1, 2020 to December 31, 2020. The security agency must be duly licensed, registered, and a member of PADPAO with proper operating permits and other statutory requirements. It must have been engaged in the business for at least three (3) years and the clients being served for the last three years is at least three (3) procuring entities. The description of an eligible bidder is contained in the Bidding Documents, particularly, Section II - Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

5. Interested bidders may obtain further information from the BAC Secretariat of Philippine Science High School CALABARZON Region and inspect the Bidding Documents at the address given below during *regular working hours (8:00am to 5:00pm)*.
6. A complete set of Bidding Documents may be acquired by interested Bidders starting *November 26, 2019 up to before the bid opening on December 16, 2019* from the



address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (PhP 5,000.00).


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

7. The *Philippine Science High School CALABRZON Region Campus* will hold a Pre-Bid Conference on **December 4, 2019, 10:00 am** at the **Conference Room, Administration Building, Philippine Science High School CALABRZON Region Campus**, which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat at the address below on or before **December 16, 2019 at 10:00 am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **December 16, 2019, 10:05 am** at the **Conference Room, Administration Building, Philippine Science High School CALABRZON Region Campus**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

9. The Philippine Science High School CALABRZON Region Campus reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
