



Contract Agreement Form

THIS AGREEMENT made this _____ day of JUN 26 2020, 2020 between **PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS** of Brgy. Sampaga, Batangas City, herein represented by its Campus Director, **DR. JOSE M. ANDAYA** (hereinafter called "the Entity) of the one part and **LSERV CORPORATION** of Units C & D, 21/F Petron Mega Plaza Bldg. 358 Sen. Gil Puyat Avenue, Makati City herein represented by its Authorized Signatory **MR. JOSEPH V. ANGELES** (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Procurement of Manpower Services Provider for PSHS-CALABARZON Region Campus (Outsourcing of Workforce Services for April to December, 2020) / GOODS-2020-02** and has accepted a Bid by the Supplier for the supply, delivery and installation of those goods and services in the sum of **THREE MILLION FIVE HUNDRED THOUSAND SEVEN HUNDRED FIFTY ONE PESOS ONLY (PhP3, 500, 751.00)** (hereinafter called "the Contract Price);

WHEREAS, the contract comes into force with effect from **July 1, 2020 up to December 31, 2020.**

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) Invitation to Bid;
 - (b) Supplemental Bid Bulletin
 - (c) Section II. Instruction to Bidders
 - (d) Section III. Bid Data Sheet
 - (e) Section IV. General Conditions of the Contract
 - (f) Section V. Special Conditions of the Contract
 - (g) Section VI. Schedule of Requirements
 - (h) Section VII. Technical Specifications
 - (i) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (j) the Entity's Notice of Award; and
 - (k) the Performance Security.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. The parties shall at all times exert diligence, good faith and dedication to achieve the avowed objectives of the Agreement. Any issues or difference that may arise between the parties should be resolved in an amicable manner. However, after earnest efforts to resolve the same fail, the disputes, issues or controversies arising from the interpretation or application of the terms and conditions of this Agreement shall be exclusively filed and tried in the courts of Batangas City to the exclusion of all other courts and tribunals.

This Agreement shall take effect immediately and shall remain in force unless revoked or cancelled by the parties.
