CONTRACT AGREEMENT

THIS AGREEMENT, made this 28th day of January, 2021 between PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS hereinafter called the "Entity") BERTO LUCCI BUILDERS & SUPPLY of #67 Evangelista Street, Brgy. 8, Batangas City (hereinafter called the "Contractor").

 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the
