DECLARING LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING
AWARD OF CONTRACT FOR THE PROCUREMENT OF COMPUTERS AND
COMPUTER PERIPHERALS/GOODS-2021-02

WHEREAS, the Philippine Science High School- CALABARZON Region Campus advertised the Invitation to Bid for the Procurement of Computers and Computer Peripherals/Goods-2021-02 through a posting on PhilGEPS on October 7, 2021.

WHEREAS, the Approved Budget for the Contract (ABC) of the project is **One Million Two Hundred Ninety-Nine Thousand Seven Hundred Pesos (Php 1,299,700.00)** allocated under the 2021 General Appropriations Act (GAA).

WHEREAS, it was stated in the Invitation to Bid that the open competitive bidding shall be done in compliance to the provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the Government Procurement Reform Act.

WHEREAS, a pre-procurement conference was held on July 30, 2021 through video conferencing to discuss, review, and finalize the details of the project.

WHEREAS, a pre-bid conference was held on October 15, 2021 at PSHS- CALABARZONRC, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing. Representatives from DCI Int'l. I.T. Solutions and Services Corporation, and Mediacast Digital Group Incorporated were the bidders in attendance during the said conference.

WHEREAS, Supplemental Bid/Bid Bulletin No.1 was issued and posted on PhilGEPS on October 19, 2021 to identify amendments to the delivery period and technical specifications of the goods to be purchased.

WHEREAS, in response to the said advertisement, two (2) suppliers expressed their intent to bid on the said project and purchased the Bidding Documents.

WHEREAS, the submission and opening of bids was held on October 27, 2021 at PSHS- CALABARZONRC, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing.

WHEREAS, two bidders: DCI Int'l. I.T. Solutions and Services Corporation, and Mediacast Digital Group Incorporated submitted complete bidding documents during the opening of bids.

WHEREAS, upon opening, review, and evaluation of the eligibility, technical, and financial documents, it was established that **DCI INT'L. I.T. SOLUTIONS AND SERVICES**

CORPORATION had the lowest calculated bid with a bid price of One Million One Hundred Eighty-Two Thousand Pesos (Php 1,182,000.00); within the ABC.

WHEREAS, a post-qualification evaluation was conducted by members of the Technical Working Group (TWG) on October 29- November 5, 2021 to examine, verify, and validate all the eligibility, technical, and financial requirements submitted by the bidder. They conducted a video conference and sent online correspondences with the representatives of the bidder, DCI Int'l. I.T. Solutions and Services Corporation. They likewise checked the satisfactory performance of the bidder with a previous client, the Philippine Army through a telephone call and email confirmation with Sgt. Richie C. Mantile, Delivery/Inspection Specialist/NCO representative.

WHEREAS, upon post-qualification evaluation, **DCI INT'L. I.T. SOLUTIONS AND SERVICES CORPORATION** was deemed qualified in all the requirements and conditions specified in the bidding documents and was established as a responsive bidder.
