DECLARING LOWEST RESPONSIVE PRICE OFFER AND RECOMMENDING AWARD
OF CONTRACT FOR THE PROCUREMENT OF TECHNICAL AND SCIENTIFIC
EQUIPMENT FOR THE LABORATORIES OF THE CURRICULUM
AND INSTRUCTION DIVISION/GOODS-2021-03

WHEREAS, the Philippine Science High School- CALABARZON Region Campus advertised the Invitation to Bid for the project Procurement of Technical and Scientific Equipment for the Laboratories of the Curriculum and Instruction Division/GOODS-2021-03 through a posting on PhilGEPS (Philippine Government Electronic Procurement System) on October 21, 2021.

WHEREAS, the Approved Budget for the Contract (ABC) of the project is Seven Million Pesos (Php 7,000,000.00) allocated under the 2021 General Appropriations Act (GAA).

WHEREAS, it was stated in the Invitation to Bid that the open competitive bidding shall be done in compliance to the provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the Government Procurement Reform Act.

WHEREAS, a pre-procurement conference was held on October 1 and October 18, 2021 through video conferencing to discuss, review, and finalize the details of the project.

WHEREAS, a pre-bid conference was held on October 29, 2021 at PSHS- CALABARZONRC, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing. Also in attendance during the conference were representatives of various interested bidders.

WHEREAS, Supplemental Bid/Bid Bulletin No.1 was issued and posted on PhilGEPS on November 2, 2021 to identify amendments to the technical specifications of the goods to be purchased.

WHEREAS, seven (7) suppliers expressed their intent to bid on the said project and purchased the Bidding Documents.

WHEREAS, the submission and opening of bids was held on November 10, 2021 at PSHS- CALABARZONRC, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing.

WHEREAS, all seven bidders: Rainphil Inc.; XPRT Ventures Inc.; Omnifab, Inc.; Micro-biological Laboratory, Inc.; Noveaulab Asia Corporation; Alcaport Trade; and ITS Science Phils., Inc. submitted complete bidding documents during the opening of bids. Representatives of XPRT Ventures Inc. and Omnifab Inc. were personally present during the opening of bids while the others opted to attend online via video conferencing.

WHEREAS, upon opening, review, and evaluation of the eligibility, technical, and financial documents, it was established that the following bidders have the lowest calculated bid price for the indicated lots: **NOVEAULAB ASIA CORPORATION** for Lot 1, 13, and 14; **ITS SCIENCE PHILS. INC.** for Lot 4, 7, and 15; **XPRT VENTURES INC.** for Lot 6, 10, 11, and 21; **MICRO-BIOLOGICAL LABORATORY, INC.** for Lot 9; and **OMNIFAB, INC.** for Lot 23; all within the ABC.

WHEREAS, no bids were received for Items 2, 3, 5, 8, 12, 16, 17, 18, 19, 20, 22, 24, 25, and 26. Failure of bidding for the said items was declared through BAC Resolution No. 075, s. 2021 dated November 11, 2021.

WHEREAS, a post-qualification evaluation was conducted by members of the Technical Working Group (TWG) on November 12- 18, 2021 to examine, verify, and validate all the eligibility, technical, and financial requirements submitted by the bidders. They visited the main offices of the bidders and checked their performance with previous clients through telephone calls and electronic mails.

WHEREAS, upon post-qualification evaluation, XPRT Ventures Inc.; Omnifab, Inc.; Micro-biological Laboratory, Inc.; Noveaulab Asia Corporation; and ITS Science Phils., Inc. were deemed qualified in all the requirements and conditions specified in the bidding documents and were established as responsive bidders.

WHEREAS, the combined bid amount of the lowest and most responsive bids for this project is **FOUR MILLION THREE HUNDRED SEVENTEEN THOUSAND NINETY-THREE PESOS (Php 4,317,093.00)**. The variance from the ABC is Php 2,682,907.00.

NOW, THEREFORE, we, the members of the Bids and Awards Committee for Goods and Consulting Services, hereby RESOLVE as it is hereby RESOLVED
