**WHEREAS**, the Philippine Science High School- CALABARZON Region Campus advertised the Invitation to Bid for the Procurement of Furniture for the Fabrication Laboratory of the Curriculum and Instruction Division/Goods-2021-06 through a posting on PhilGEPS (Philippine Government Electronic Procurement System) on November 3, 2021.

**WHEREAS**, the Approved Budget for the Contract (ABC) of the project is **One Million Seven Hundred Forty-Six Thousand Seven Hundred Fifty Pesos (Php 1,746,750.00)** allocated under the General Appropriations Act of 2021 (GAA 2021).

**WHEREAS**, it was stated in the Invitation to Bid that the open competitive bidding shall be done in compliance to the provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the Government Procurement Reform Act.

**WHEREAS**, a pre-procurement conference was held on November 2, 2021 through video conferencing to discuss, review, and finalize the details of the project.

**WHEREAS**, a pre-bid conference was held on November 11, 2021 at PSHS- CALABARZON Region Campus, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing. In attendance during the said conference were members of the BAC, TWG, end user/requestor, and representatives of the interested bidders.

**WHEREAS**, in response to the said advertisement, only one supplier expressed its intent to bid on the said project and purchased the Bidding Documents.

**WHEREAS**, the submission and opening of bids was held on November 23, 2021 at PSHS-CALABARZON Region Campus, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing.

**WHEREAS**, EPCZ ENTERPRISES submitted complete bidding documents and was the only bidder in attendance during the opening of bids.

**WHEREAS**, upon opening, review and evaluation of the eligibility, technical, and financial documents, it was established that **EPCZ ENTERPRISES** had the single calculated bid for the project.
