## **BAC RESOLUTION**

## DECLARING SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF SECURITY SERVICES FOR FY 2022/GOODS-2022-01

**WHEREAS**, the Philippine Science High School- CALABARZON Region Campus advertised the Invitation to Bid for the Procurement of Security Services for FY 2022/Goods-2022-01 through a posting on PhilGEPS (Philippine Government Electronic Procurement System) on November 9, 2021.

**WHEREAS,** the Approved Budget for the Contract (ABC) of the project is Two Million One Hundred Sixteen Thousand Two Hundred Four Pesos and 50/100 (Php 2,116,204.50) allocated under the 2022 National Expenditure Program (NEP).

**WHEREAS**, it was stated in the Invitation to Bid that the open competitive bidding shall be done in compliance to the provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the Government Procurement Reform Act.

WHEREAS, a pre-procurement conference was held on November 5, 2021 through video conferencing to discuss, review, and finalize the details of the project.

**WHEREAS,** a pre-bid conference was held on November 17, 2021 at PSHS- CALABARZON Region Campus, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing. In attendance during the said conference were members of the BAC, TWG, end user/requestor, and representatives of the interested bidders.

**WHEREAS,** in response to the said advertisement, only one supplier expressed its intent to bid on the said project and purchased the Bidding Documents.

**WHEREAS,** the submission and opening of bids was held on November 29, 2021 at PSHS-CALABARZON Region Campus, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing.

WHEREAS, MAXIMUM SECURITY AND SERVICES CORPORATION submitted complete bidding documents and was the only bidder in attendance during the opening of bids.

WHEREAS, upon opening, review and evaluation of the eligibility, technical, and financial documents, it was established that MAXIMUM SECURITY AND SERVICES CORPORATION had the single calculated bid for the project.

They conducted a video conference and sent online correspondences with its representatives. They likewise checked the performance of the bidder with a previous client through Mr. Ryan Oliver Gonzales, Finance Officer of the Legislative Bureau from the House of Representatives.

WHEREAS, upon post-qualification evaluation, MAXIMUM SECURITY AND SERVICES CORPORATION was deemed qualified in all the requirements and conditions specified in the bidding documents and was established as a responsive bidder.

**NOW, THEREFORE, We**, the members of the Bids and Awards Committee for Goods and Consulting Services, hereby RESOLVE as it is hereby RESOLVED

- a. to declare MAXIMUM SECURITY AND SERVICES CORPORATION as the SINGLE CALCULATED AND RESPONSIVE BIDDER (Winning Bidder) with a bid quote amounting to TWO MILLION ONE HUNDRED SIX THOUSAND TWO HUNDRED FIFTY-NINE PESOS AND NINETY CENTAVOS (PHP 2,106,259.92),
- b. to recommend award of contract to **MAXIMUM SECURITY AND SERVICES CORPORATION**, and
- c. to recommend for approval by the Campus Director of the Philippine Science High School- CALABARZON Region Campus the foregoing findings.
