



BAC RESOLUTION

DECLARING SINGLE/LOWEST RESPONSIVE PRICE OFFER AND RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF TECHNICAL AND SCIENTIFIC EQUIPMENT FOR THE LABORATORIES OF THE CURRICULUM AND INSTRUCTION DIVISION (REBIDDING)/GOODS-2021-08

Resolution No. 101, s. 2021 20 December 2021

WHEREAS, the Philippine Science High School- CALABARZON Region Campus advertised the Invitation to Bid for the project Procurement of Technical and Scientific Equipment for the Laboratories of the Curriculum and Instruction Division (Rebidding)/GOODS-2021-08 through a posting on PhilGEPS (Philippine Government Electronic Procurement System) on November 25, 2021.

WHEREAS, the Approved Budget for the Contract (ABC) of the project is Two Million Six Hundred Eighty-Two Thousand Nine Hundred Pesos Only (Php 2,682,900.00) allocated under the 2021 General Appropriations Act (GAA).

WHEREAS, it was stated in the Invitation to Bid that open competitive bidding shall be done in compliance to the provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the Government Procurement Reform Act.

WHEREAS, a pre-procurement conference was held on November 24, 2021 through video conferencing to discuss, review, and finalize the details of the project.

WHEREAS, a pre-bid conference was held on December 3, 2021 at PSHS-CALABARZONRC, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing. In attendance during the conference were the members of the Bids and Awards Committee, Technical Working Group, BAC Secretariat, end-users/requestors, and representatives of various interested bidders.

WHEREAS, Supplemental Bid/Bid Bulletin No.1 was issued and posted on PhilGEPS on December 7, 2021 to identify some amendments to the technical specifications of Lot 2, Muffle Furnace.

WHEREAS, three (3) suppliers expressed their intent to bid on the said project and purchased the Bidding Documents.

WHEREAS, the submission and opening of bids was held on December 15, 2021 at PSHS-CALABARZONRC, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing.

WHEREAS, all three bidders: Red Gutz Trading, Camprock Analytika Ezzentialez Trading, and XPRT Ventures Inc. submitted complete bidding documents and attended the opening of bids in the campus.

WHEREAS, upon opening, review, and evaluation of the eligibility, technical, and financial documents, it was established that the following bidders have the single/lowest calculated bid price for the indicated lots: RED GUTZ TRADING for Lot 7, CAMPROCK ANALYTIKA EZZENTIALEZ TRADING for Lot 1, and XPRT VENTURES INC. for Lots 2, 3, and 4; all within the ABC. Details of the bids are reflected in the Abstract of Bids, Detailed Comparative Analysis and Bid Evaluation Report.

WHEREAS, NO BIDS were received for Lot 5 (Woodcraft and Metal Fabrication Equipment), Lot 6 (Sewing Equipment), and Lot 8 (Spray System and Dust Collection Equipment).

WHEREAS, a post-qualification evaluation was conducted by members of the Technical Working Group (TWG) on December 16- 17, 2021 to examine, verify, and validate all the eligibility, technical, and financial requirements submitted by the bidders. They conducted video conferences with the bidders and communicated other additional concerns through email and online messaging. They likewise verified the contracts and the performance of the bidders with previous clients.

WHEREAS, upon post-qualification evaluation, RED GUTZ TRADING, CAMPROCK ANALYTIKA EZZENTIALEZ TRADING, and XPRT VENTURES INC. were deemed qualified in all the requirements and conditions specified in the bidding documents and were established as responsive bidders.

WHEREAS, the combined bid amount of the single/lowest and most responsive bids for this project is ONE MILLION FOUR HUNDRED SIXTY-FIVE THOUSAND EIGHT HUNDRED FIFTY-THREE PESOS AND THIRTY-THREE CENTAVOS (Php 1,465,853.33). The variance from the ABC is Php 1,217,046.67.

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods and Consulting Services, hereby RESOLVE as it is hereby RESOLVED
