



BAC RESOLUTION
DECLARING SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING
AWARD OF CONTRACT FOR THE PROCUREMENT OF SUBSCRIPTION TO
ELECTRONIC LIBRARY RESOURCES AND RESEARCH TOOLS
/GOODS-2021-05

WHEREAS, the Philippine Science High School- CALABARZON Region Campus advertised the Invitation to Bid for the Procurement of Subscription to Electronic Library Resources and Research Tools/Goods-2021-05 through a posting on PhilGEPS (Philippine Government Electronic Procurement System) on October 21, 2021.

WHEREAS, the Approved Budget for the Contract (ABC) of the project is Three Million Four Hundred Fifty Thousand Pesos (Php 3,450,000.00) allocated under the General Appropriations Act of 2021 (GAA 2021).

WHEREAS, it was stated in the Invitation to Bid that the open competitive bidding shall be done in compliance to the provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the Government Procurement Reform Act.

WHEREAS, a pre-procurement conference was held on October 18, 2021 through video conferencing to discuss, review, and finalize the details of the project.

WHEREAS, a pre-bid conference was held on October 29, 2021 at PSHS- CALABARZON Region Campus, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing. In attendance during the said conference were members of the BAC, TWG, end user/requestor, and representatives of the bidders, Libtech Source Philippines. Inc. and CE-Logic Inc.

WHEREAS, Supplemental Bid/Bid Bulletin No.1 was issued and posted on PhilGEPS on November 2, 2021 to identify amendments to the payment scheme and technical specifications of the goods to be purchased.

WHEREAS, in response to the said advertisement, only one supplier expressed its intent to bid on the said project and purchased the Bidding Documents.

WHEREAS, the submission and opening of bids was held on November 10, 2021 at PSHS- CALABARZON Region Campus, Sitio Sampaga West, Barangay Sampaga, Batangas City and through video conferencing.

WHEREAS, CE-LOGIC INC. submitted complete bidding documents and was the only bidder in attendance during the opening of bids.



WHEREAS, upon opening, review and evaluation of the eligibility, technical, and financial documents, it was established that **CE-LOGIC INC.** had the single calculated bid for Items 1, 2, 3, and 6.

WHEREAS, no bids were received for Item 4 (Grammarly Grammar Checker- Annual Subscription) and Item 5 (Elsevier Science Direct E-Books). Failure of bidding for the two items was declared through BAC Resolution No. 074, s. 2021 dated November 11, 2021.

WHEREAS, a post-qualification evaluation was conducted by members of the Technical Working Group (TWG) on November 12- 18, 2021 to examine, verify, and validate all the eligibility, technical, and financial requirements submitted by the bidder. They conducted a video conference and sent online correspondences with the representatives of the bidder and checked the satisfactory performance of the bidder with a previous client, the University Libraries of St. Louis University, Baguio City.

WHEREAS, upon post-qualification evaluation, **CE-LOGIC INC.** was deemed qualified in all the requirements and conditions specified in the bidding documents and was established as a responsive bidder.

WHEREAS, the combined bid amounts of the four single and responsive bids with respect to each item is **Two Million Two Hundred Thousand Pesos (Php 2,200,000.00)**. The variance from the ABC is Php 1,250,000.00.

NOW, THEREFORE, we, the members of the Bids and Awards Committee for Goods and Consulting Services, hereby **RESOLVE** as it is hereby **RESOLVED**
