CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of **DEC 10 2021** between **PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS Brgy. Sampaga Batangas City** of the Philippines (hereinafter called "the Entity") of the one part and **XPRT VENTURES INC. of Unit A Lot 3 Blk. 7. Ponte Verde Subd. San Rafael, Sto. Tomas City, Batangas** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Technical and Scientific Equipment for the Laboratories of the Curriculum and Instruction Division/GOODS-2021-03 – Lot 6 – 1 unit Autoclave (Electric-Heated Vertical Steam Sterilizer), 220V at One Hundred Forty-Eight Thousand Pesos Only (P148,000.00) – Lot 10 – 2 units Top Loading Balance at Fifty Thousand Pesos Only (P50,000.00) – Lot 11 – 1 unit Analytical Balance at Ninety Thousand Pesos Only (P90,000.00) – and Lot 21 – 1 lot Viscometer at Ninety-Eight Thousand Eight Hundred Eighty-Eight Pesos Only (P98,888.00)**, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **THREE HUNDRED EIGHTY-SIX THOUSAND EIGHT HUNDRED EIGHTY-EIGHT PESOS ONLY (P386,888.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **THREE HUNDRED EIGHTY-SIX THOUSAND EIGHT HUNDRED EIGHTY-EIGHT PESOS ONLY (P386,888.00)** or such other sums as may be ascertained, **XPRT VENTURES, INC.** agrees to provide **Technical and Scientific Equipment for the Laboratories of the Curriculum and Instruction Division (Lots 6, 10, 11, and 21)** in accordance with its Bid.
4. The **PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
