## **CONTRACT AGREEMENT**

THIS AGREEMENT made the \_\_\_\_ day of \_\_\_\_\_ between PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS Brgy. Sampaga Batangas City of the Philippines (hereinafter called "the Entity") of the one part and CE-LOGIC INC. of EDSA South Triangle, Quezon City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Subscription to Electronic Library Resources and Research Tools – Lot 1 - Gale Reference Complete: MultiDisciplinary Periodicals (Annual Subscription) at Eight Hundred Thousand Pesos Only (P800,000.00) – Lot 2 – Gale in Context Suite (Annual Subscription) at Six Hundred Thousand Pesos Only (P600,000.00) – Lot 3 – PressReader E-Newspaper and Magazines (Annual Subscription) at Three Hundred Thousand Pesos Only (P300,000.00) – and Lot 6 – Gale Virtual Reference Library (Ebooks) at Five Hundred Thousand Pesos Only (P500,000.00), and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of TWO MILLION TWO HUNDRED THOUSAND PESOS ONLY (Php2, 200,000.00) (hereinafter called "the Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:

    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of TWO MILLION TWO HUNDRED THOUSAND PESOS ONLY (Php2, 200,000.00) or such other sums as may be ascertained, CE-LOGIC INC. agrees to provide Subscription to Electronic Library Resources and Research Tools (Lots 1, 2, 3, and 6) in accordance with its Bid.
- The PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
