



Contract Agreement Form for the Procurement of Furniture for the Fabrication Laboratory of the Curriculum and Instruction Division/GOODS-2021-06

CONTRACT AGREEMENT

THIS AGREEMENT made the 27th day of December 20 21 between **PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS Brgy. Sampaga Batangas City** of the Philippines (hereinafter called "the Entity") of the one part and **EPCZ ENTERPRISES of Sitio Calumpang, Alangilan, Batangas City, Batangas** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Furniture for the Fabrication Laboratory of the Curriculum and Instruction Division/GOODS-2021-06** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION SIX HUNDRED NINETY-SIX THOUSAND THREE HUNDRED SIXTY-FIVE PESOS ONLY (Php1,696,365.00)** (hereinafter called "the Contract Price") within 90 calendar days after the receipt of the Notice to Proceed.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

4. The **PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

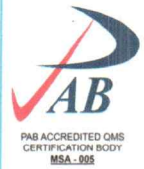
