CONTRACT AGREEMENT

THIS AGREEMENT made the JAN 07 2022 day of _____ 20____ between **PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS Brgy. Sampaga Batangas City** of the Philippines (hereinafter called "the Entity") of the one part and **iVALUE TECHNOLOGIES CORP. of Unit 238 Comfoods Building Sen Gil Puyat Ave, cor Chino Roces St., Makati City** (hereinafter called "the Supplier") of the other part;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **SIX HUNDRED NINETY-NINE THOUSAND PESOS ONLY (Php699,000.00)** or such other sums as may be ascertained, **iVALUE TECHNOLOGIES CORP.** agrees to provide **Private Automated**





