CONTRACT AGREEMENT

10 JAN 2022

THIS AGREEMENT made the _____ day of _____ 20____ between **PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS Brgy. Sampaga Batangas City** of the Philippines (hereinafter called "the Entity") of the one part and **MAXIMUM SECURITY AND SERVICES CORPORATION of 5th Floor, Unibond Building, No. 103, Sgt. Catolos St., Brgy. Immaculate Conception, Cubao, Quezon City** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Security Services for FY 2022/GOODS-2022-01** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION ONE HUNDRED SIX THOUSAND TWO HUNDRED FIFTY-NINE AND 92/100 (Php2,106,259.92)** (hereinafter called "the Contract Price") from January 1, 2022 to December 31, 2022.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the




Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **TWO MILLION ONE HUNDRED SIX THOUSAND TWO HUNDRED FIFTY-NINE AND 92/100 (Php2,106,259.92)** or such other sums as may be ascertained, **MAXIMUM SECURITY AND SERVICES CORPORATION** agrees to provide **Security Services** for **FY 2022** in accordance with its Bid.
4. The **PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
