CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of ____ 20___ between PHILIPPINE SCIENCE HIGH SCHOOL CALABARZON REGION CAMPUS Brgy. Sampaga Batangas City of the Philippines (hereinafter called "the Entity") of the one part and R2D2 TRADING of 0823 Langka St. Sta. Ursula Subd., Brgy. Batingan, Binangonan, Rizal (hereinafter called "the Supplier") of the other part;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
