## BAC RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT OF SECURITY SERVICES FOR FY 2023/GOODS-2023-02

RESOLUTION NO. 140, s. 2022 December 19, 2022

WHEREAS, the Philippine Science High School - CALABARZON Region Campus advertised on PhilGEPS the project PROCUREMENT OF SECURITY SERVICES FOR FY 2023/GOODS-2023-02 on November 28, 2022, with a total ABC of THREE MILLION TWO HUNDRED EIGHTY-EIGHT THOUSAND NINE HUNDRED FIFTEEN PESOS ONLY (Php3,288,915.00);

WHEREAS, the mode of procurement used for the project was Competitive Public Bidding under the provisions in the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (Updated as of 13 October 2022);

WHEREAS, prior to posting, a Pre-Procurement Conference was held on November 23, 2022, 11:30 AM, via Zoom Cloud Meetings;

WHEREAS, a Pre-Bid Conference was conducted on December 6, 2022, 10:00 AM, via Google Meet, and was attended by FOUR (4) bidders, which are as follows:

- a) Delta Maroon Security Agency Corp.
- b) Arviter Tiop Top of the Line Security Investigation Specialist
- c) Maximum Security Services and Services Corporation
- d) D'Great Stallion Security Agency Inc.

WHEREAS, Supplemental/Bid Bulletin No. 1 was released on December 9 amending the date of the Opening of Bids from December 16 to December 19, 2022, at 02:30 PM;

WHEREAS, the Opening of Bids was held on December 19, 2022 at 02:30 PM, and no bidders were in attendance;

WHEREAS, Section 35.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (Updated as of 13 October 2022) provides that "There shall be failure of bidding if:

a. No bids are received:"

WHEREAS, Section 35.2 states that "In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including cost estimates;"

WHEREAS, Section 35.3 states that based on its findings, the BAC shall revise the terms, conditions and if necessary, adjust the ABC subject to the required approvals, and conduct a rebidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR;"
