BAC RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT AND IMPLEMENTATION (REBIDDING) OF FIRE PROTECTION SYSTEM (UTILIZING THE DESIGN AND BUILD SCHEME)/INFRA-2023-02

RESOLUTION NO. 003, s. 2023 18 January 2023

WHEREAS, the Philippine Science High School - CALABARZON Region Campus (PSHS-PhilGEPS the project PROCUREMENT advertised on CALABARZONRC) IMPLEMENTATION (REBIDDING) OF FIRE PROTECTION SYSTEM (UTILIZING THE DESIGN AND BUILD SCHEME)/INFRA-2023-03 on December 29, 2022, with a total ABC of TWENTY-TWO MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P22,500,000.00);

WHEREAS, the mode of procurement used for the project was Competitive Public Bidding under the provisions in the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (Updated as of 11 January 2023);

WHEREAS, a Mandatory Review and Evaluation of the Terms, Conditions, and Specifications in the Bidding Documents, including its Cost Estimates was held on December 27, 2022 at the Conference Room, Administration Building, PSHS-CALABARZONRC;

WHEREAS, prior to posting, a Pre-Procurement Conference was held on December 28, 2022, 09:00 AM, via Zoom Cloud Meetings;

WHEREAS, a Pre-Bid Conference was conducted on January 6, 2023, 10:00 AM, via Google Meet, and was attended by only ONE (1) bidder, specifically:

a) ALARMNET INC.

WHEREAS, TWO (2) bidders were shown in the Document Request List on December 29, 2022;

WHEREAS, the Opening of Bids was held on January 18, 2023 at 10:00 AM, and no bidders were in attendance;

WHEREAS, Section 35.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (Updated as of 11 January 2023) provides that "There shall be failure of bidding if:

a. No bids are received;"

WHEREAS, Section 35.2 states that "In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including cost estimates;"

WHEREAS, Section 35.3 states that based on its findings, the BAC shall revise the terms, conditions and if necessary, adjust the ABC subject to the required approvals, and conduct a rebidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR;"
