MANAGEMENT COMMITTEE Resolution No. 57 s. 2022 November 3, 2022

RESOLUTION UNANIMOUSLY RECOMMENDING AWARD OF CONTRACT TO JODANS ENGINEERING OF THE PROJECT, CONSTRUCTION OF BOYS AND GIRLS RESIDENCE HALL FOR SENIOR HIGH (UTILIZING THE DESIGN AND BUILD SCHEME)/INRA-2023-01 IN THE TOTAL AMOUNT OF FIFTY NINE MILLION FOUR HUNDRED FORTY FOUR THOUSAND FOUR HUNDRED SIXTY NINE PESOS AND 23/100 (P 59,444,469.23)

WHEREAS, the PSHS - CALABARZON Region Campus (CALABARZONRC) was provided funds for the Construction of Boys and Girls Residence Hall for Senior High the amount of Sixty Million Pesos (P60,000,000.00) under the FY 2023 National Expenditure Program (NEP);

WHEREAS, in compliance with Government Procurement Policy Board Circular No. 06-2019, the Head of Procuring Entity instructed the conduct of early procurement activities for the aforesaid infrastructure project, using P60,000,000.00 being the NEP budget level as the Approved Budget for the Contract;

WHEREAS, the procurement activity commenced with the conduct of pre-procurement conference by the PSHS-CALABARZONRC Bids and Awards Committee (BAC) on September 27, 2022 to discuss, review and finalize the details of the procurement project;

WHEREAS, the PSHS-CALABARZONRC BAC advertised the Invitation to Apply for Eligibility and to Bid for the project on September 29, 2022 through posting on the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous place in the Campus;

WHEREAS, the pre-bid conference was held on October 7, 2022, with four (4) bidders in attendance, namely, Berto Lucci Builders and Supply, Dezmar Construction and Development, Jodans Engineering, and PL Juan Construction, Inc., from which a supplemental bid bulletin was needed to be issued on October 11, 2022 to clarify certain portions of the Philippine Bidding Documents and Terms of Reference such as the contracts similar to the project and list of required documents;

WHEREAS, only one prospective bidder purchased the bidding documents and submitted its bid before the scheduled deadline of submission and attended the opening of bids on October 19, 2022;

WHEREAS, during bid opening, the complete set of bid documents submitted by Jodans Engineering and a bid price in the amount of P59,444,469.23 was found to be complying in all aspects of the bidding requirements;

WHEREAS, upon careful examination, validation and verification of the eligibility, technical and financial requirements submitted by Jodans Engineering, the Single Calculated Bid, its

bid is found to be responsive and complying to with the eligibility, technical and financial requirements under the bidding documents and considered Post-Qualified;

WHEREAS, after careful deliberation of the BAC and its Technical Working Group, considering the results obtained upon bid evaluation and post-qualification, the bid of Jodans Engineering was recommended to be the Single Calculated and Responsive Bid, with recalculated bid price of FiftyNine Million Five Hundred Twenty Seven Thousand Four Hundred Ninety Four Pesos and 25/100 (P59,527,494.25), still within the ABC, with 0.926% variance;

WHEREAS, the BAC underwent procurement activities for the procurement project and fulfilled all the required procedures and conditions sets forth in Republic Act No. 9184 and its Revised Implementing Rules and Regulations;

NOW THEREFORE, WE, THE MEMBERS OF THE MANAGEMENT COMMITTEE, HEREBY RESOLVE, AS IT IS HEREBY RESOLVED TO RECOMMEND THE AWARD OF CONTRACT TO JODANS ENGINEERING FOR THE PROJECT, CONSTRUCTION OF BOYS AND GIRLS RESIDENCE HALL FOR SENIOR HIGH (UTILIZING THE DESIGN AND BUILD SCHEME)/INRA-2023-01 IN THE TOTAL AMOUNT OF FIFTY NINE MILLION FOUR HUNDRED FORTY FOUR THOUSAND FOUR HUNDRED SIXTY NINE PESOS AND 23/100 (P 59,444,469.23).
