MANAGEMENT COMMITTEE Resolution No. 61 s. 2022 December 23, 2022

RESOLUTION UNANIMOUSLY APPROVING AWARD OF CONTRACT FOR THE PROJECT, SUPPLY AND DELIVERY OF MATERIALS FOR SECURITY IMPROVEMENT OF EXISTING PERIMETER FENCE

WHEREAS, the PSHS-CALABARZON Region Campus (CALABARZONRC) has been growing in terms of student and employee population and continuously acquires equipment and facilities, making security and safety of the school a priority concern;

WHEREAS, installation of barbed wires in the existing concrete perimeter fence is the most practical option in terms of cost and functionality;

WHEREAS, the cost of security improvement implements is programmed and prioritized in the funds allocated in FY 2023 and in compliance with Government Procurement Policy Board (GPPB) Circular No. 06-2019, the Head of Procuring Entity instructed the conduct of early procurement activities for the aforesaid project, with One Million Nine Hundred Fifty Four Thousand Five Hundred Ninety Pesos (P1.954,590.00) as the Approved Budget for the Contract;

WHEREAS, the procurement activities commenced with the conduct of pre-procurement conference by the PSHS-CALABARZONRC Bids and Awards Committee (BAC) on October 7, 2022 to discuss, review and finalize the details of the procurement project;

WHEREAS, the PSHS-CALABARZONRC BAC advertised the Invitation to Apply for Eligibility and to Bid for the project through posting in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous place in the Campus:

WHEREAS, the pre-bid conference was held on October 19, 2022 with three (3) bidders in attendance, namely, Omnicon Builders, Up Town Industrial Sales, Inc. and RM & S Gen. Merchandise, together with the members of the BAC and representatives of End-User Unit;

WHEREAS, the aforesaid prospective bidders purchased the bidding documents and submitted their respective bids before the scheduled deadline of submission and attended the opening of bids on November 2, 2022;

WHEREAS, during bid opening, it was found that Omnicon Builders failed to submit a bid security nor a Notarized Bid Securing Declaration, while Up Town Industrial Sales, Inc. failed to submit the Audited Financial Statement, hence both were disqualified from the opening of financial bid;

WHEREAS, the complete set of bid documents submitted by RM & S Gen. Merchandise and a bid price in the amount of One Million Eight Hundred Fifty One Thousand Nine Hundred

Twenty Pesos (P1,851,920.00) was found to be complying in all aspects of the bidding requirements:

WHEREAS, upon careful examination, validation and verification of the eligibility, technical and financial requirements submitted by RM & S Gen. Merchandise, the Single Calculated Bid, its bid is found to be responsive and complying to the eligibility, technical and financial requirements under the bidding documents and was subjected to post-qualification evaluation;

WHEREAS, after careful deliberation of the BAC and its Technical Working Group, considering the results obtained from bid evaluation and post-qualification, the bid of RM & S Gen. Merchandise was declared the Single Calculated and Responsive Bid and was recommended for award of contract:

WHEREAS, the BAC underwent procurement activities for the project and fulfilled all the required procedures and conditions in accordance with Republic Act No. 9184 and its Revised Implementing Rules and Regulations;

NOW THEREFORE, WE, THE MEMBERS OF THE MANAGEMENT COMMITTEE, HEREBY RESOLVE, AS IT IS HEREBY RESOLVED TO APPROVE THE AWARD OF CONTRACT TO RM & S GEN. MERCHANDISE FOR THE PROJECT, SUPPLY AND DELIVERY OF MATERIALS FOR SECURITY IMPROVEMENT OF EXISTING PERIMETER FENCE IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED FIFTY ONE THOUSAND NINE HUNDRED TWENTY PESOS (P1,851,920.00), NOT EARLIER THAN THE APPROVAL AND EFFECTIVITY OF THE FY 2023 GENERAL APPROPRIATIONS ACT, AND SUBJECT TO THE LIMITATIONS OF GPPB CIRCULAR NO. 06-2019.
