



**BAC RESOLUTION DECLARING A SINGLE CALCULATED AND RESPONSIVE BID AND
RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT (REBIDDING)
OF SECURITY SERVICES FOR FY 2023**
RESOLUTION NO. 012, s. 2023
January 31, 2023

WHEREAS, the Philippine Science High School-CALABARZON Region Campus advertised the Invitation to Bid for the **PROCUREMENT (REBIDDING) OF SECURITY SERVICES FOR FY 2023** through a posting on Philippine Government Electronic Procurement System (PhilGEPS) on **December 22, 2022**;

WHEREAS, the Approved Budget for the Contract (ABC) of the project is **Three Million Eight Hundred Thousand Pesos Only (P3,800,000.00)** allocated under the National Expenditure Program (NEP) of 2023;

WHEREAS, it was stated in the Invitation to Bid that the **open competitive bidding** shall be done in compliance to the provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the Government Procurement Reform Act;

WHEREAS, prior to the posting, a **mandatory review** had been conducted on **December 19, 2022** consistent with Updated 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 stating that "In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including cost estimates;" (Section 35.2, p. 82), during which, "based on its findings, the BAC shall revise the terms, conditions and if necessary, adjust the ABC subject to the required approvals, and conduct a rebidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR;" (Section 35.3, p. 82).

WHEREAS, a **pre-procurement conference** was held on **December 21, 2022** via **Google Meet** to discuss, review, and finalize the details of the project;

WHEREAS, **Supplemental/Bid Bulletin 1** was released on **December 27, 2022** amending the date of the Opening of Bids from **January 16 to January 17, 2023** by virtue of Presidential Proclamation 111 declaring a non-working holiday in Batangas City;



WHEREAS, a pre-bid conference was held on **January 3, 2023** through video conferencing via **Google Meet**. In attendance during the said conference were members of the BAC, TWG, end user/requestor, and representative of interested bidders;

WHEREAS, **Supplemental/Bid Bulletin 2** was released on **January 3, 2023** amending the Technical Documents to include the submission of **Latest Monthly Disposition Report (MDR)** received by **Supervisory Office for Security and Investigation Agencies (SOSIA)** or **Regional Civil Security Units (RCSU)**;

WHEREAS, there were **SIX (6)** interested bidders who checked the advertisement on PhilGEPS, as indicated in the Documentary Request List between **December 26, 2022** and **January 10, 2023**;

WHEREAS, in response to the said advertisement, only **ONE (1)** bidder, **MAXIMUM SECURITY AND SERVICES CORPORATION**, expressed its intent to bid on the said project and purchased the Bidding Documents;

WHEREAS, the submission and opening of bids was held on **January 17, 2023** at the **Conference Room, Administration Building of PSHS CALABARZON Region Campus, Sitio Sampaga West, Barangay Sampaga, Batangas City**;

WHEREAS, upon opening, review, and evaluation of the eligibility, technical, and financial documents, it was established that **MAXIMUM SECURITY AND SERVICES CORPORATION** had the single calculated bid for the project;

WHEREAS, a post-qualification evaluation was conducted by members of the Technical Working Group (TWG) on **January 20, 2023** at **5th Floor Unibond Trading Bldg Cubao, Quezon City**, to examine, verify, and validate all the eligibility, technical, and financial requirements submitted by the bidder;

WHEREAS, upon post-qualification evaluation **MAXIMUM SECURITY AND SERVICES CORPORATION** was deemed qualified in all the requirements and conditions specified in the bidding documents and was established as a responsive bidder;

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods and Consulting Services, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **MAXIMUM SECURITY AND SERVICES CORPORATION** as the **SINGLE CALCULATED AND RESPONSIVE BIDDER (Winning Bidder)** with a bid quote amounting to **THREE MILLION SIX HUNDRED SIXTY-EIGHT THOUSAND FOUR HUNDRED PESOS AND 82/100 (PhP3,668,400.82)**;

- b. To recommend the award of contract to **MAXIMUM SECURITY AND SERVICES CORPORATION**, and
- c. To recommend for approval by the Campus Director of the Philippine Science High School- CALABARZON Region Campus the foregoing findings.
