## BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT FOR PROCUREMENT (REBIDDING) OF MOTOR VEHICLE FOR FY 2023/GOODS-2023-06

WHEREAS, the Philippine Science High School - CALABARZON Region Campus (PSHS-CALABARZONRC) advertised on PhilGEPS the project PROCUREMENT OF MOTOR VEHICLE FOR FY 2023/GOODS-2023-04 on February 21, 2023, with a total ABC of ONE MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P1,500,000.00);

WHEREAS, the mode of procurement used for the project was Competitive Public Bidding under the provisions in the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (Updated as of 11 January 2023);

WHEREAS, prior to posting, a Pre-Procurement Conference was held on February 17, 2023, 11:00 AM, via Zoom Cloud Meetings;

WHEREAS, a Pre-Bid Conference was conducted on March 1, 2023, 11:00 AM, via Google Meet, and NO bidder was in attendance;

WHEREAS, THREE (3) bidders were shown in the Document Request List between February 21-22, 2023;

WHEREAS, the Opening of Bids was held on March 13, 2023 at 02:30 PM at the Conference room of the Administration Bldg., and NO bidder/s were in attendance;

WHEREAS, Section 35.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (Updated as of 11 January 2023) provides that "There shall be failure of bidding if:

a. No bids are received;"

WHEREAS, Section 35.2 states that "In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including cost estimates;"

WHEREAS, Section 35.3 states that based on its findings, the BAC shall revise the terms, conditions and if necessary, adjust the ABC subject to the required approvals, and conduct a rebidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR;"

WHEREAS, the members of the Bids and Awards Committee for Goods and Consulting Services, RESOLVED on May 13, 2023 through BAC Resolution No. 034 to declare a failure of bidding for the PROCUREMENT OF MOTOR VEHICLE FOR FY 2023/GOODS-2023-04 and to recommend the conduct of a mandatory review of the "terms, conditions, and specifications in the Bidding Documents, including cost estimates" of the project to determine the reason for the failure of bidding;



WHEREAS, the Opening of Bids was held on May 9, 2023 at 10:00 AM, at Conference Rm., Administration Bldg., PSHS-CALABARZONRC, Sitio Sampaga West, Brgy. Sampaga, Batangas City;

WHEREAS, only one (1) bidder, TOYOTA BATANGAS CITY INC., expressed its intent to bid on the said project and purchased the Bidding Documents prior to the Opening of Bids;

WHEREAS, upon opening, review, and evaluation of the eligibility, technical, and financial documents, it was established that TOYOTA BATANGAS CITY INC. has the single calculated bid for the project;

WHEREAS, a post-qualification evaluation was conducted by the members of the Technical Working Group (TWG) on May 15, 2023 at Sitio 6 Diversion Road, Barangay Balagtas, Batangas City, to examine, verify, and validate all the eligibility, technical, and financial requirements submitted by the bidder;

WHEREAS, upon post-qualification evaluation TOYOTA BATANGAS CITY INC. was deemed qualified in all the requirements and conditions specified in the bidding documents and was established as a responsive bidder;

WHEREAS, after the inspection of the motor vehicle through a test drive in order to determine its road-worthiness without an additional cost on the part of the Procuring Entity, it shall be returned to the casa (Toyota Service center) pending the approval of the Inspection and Acceptance Report from the Inspectorate Committee;

NOW, **THEREFORE**, We, the members of the Bids and Awards Committee for Goods and Consulting Services, hereby RESOLVE as it is hereby RESOLVED:

- a. To declare TOYOTA BATANGAS CITY INC. as the SINGLE CALCULATED AND RESPONSIVE BIDDER (Winning Bidder) with a bid quote amounting to ONE MILLION FOUR HUNDRED NINETY-EIGHT THOUSAND FOUR HUNDRED PESOS ONLY (PHP1,498,400.00);
- b. To recommend award of contract to TOYOTA BATANGAS CITY INC., and
- To recommend for approval by the Campus Director of the Philippine Science High School- CALABARZON Region Campus the foregoing findings.
